Elevator Evacuation Plan with Elevator Designation, Ground Floor



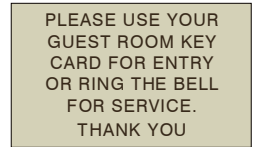
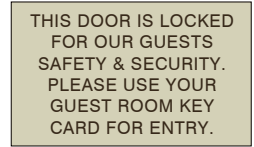

MOUTH-TO-MOUTH RESUSCITATION


A - AIRWAY

1. Clear the mouth.
2. Push or pull jaw into a jutting out position.



B - BREATHING

3. Pinch nose SHUT.
4. Cover victim's mouth with your mouth. BLOW until chest rises: for BABIES; cover mouth and nose.
5. Remove your mouth. Listen for return air. Repeat 12 to 15 times per minute.



CAUTION: If a neck injury sign appears, move the lower jaw forward without tilting the head to open the airway. Rest your elbow on the surface which the victim is laying. Move the lower jaw forward with both hands, one on each side.
