## POOL AND SPA SIGNAGE

### POOL AREA USE

**FOR YOUR SAFETY, IT IS REQUIRED THAT YOU OBSERVE THE FOLLOWING:**

- REGISTERED GUESTS ONLY.
- ALL CHILDREN UNDER 14 MUST BE WITH AN ADULT.
- RUNNING AND HORSEPLAY ARE PROHIBITED.

- SHIRTS AND SHOES REQUIRED IN THE HOTEL LOBBY.

- BE AWARE OF DEPTH MARKINGS AT ALL TIMES.

- INDIVIDUALS ASSUME THE RISK FOR ANY INJURIES SUSTAINED WHILE USING POOL FACILITIES.
- ALWAYS PRACTICE WATER SAFETY AND COURTESY.
- SHOWER BEFORE ENTERING POOL.
- CHILDREN WHO ARE NOT TOILET TRAINED MUST WEAR SWIM DIAPERS WITH RUBBER PANTS OVER THEM.

- FOOD AND GLASS OBJECTS ARE NOT PERMITTED IN SPA AREA.
- MAXIMUM TEMPERATURE 104° FAHRENHEIT.
