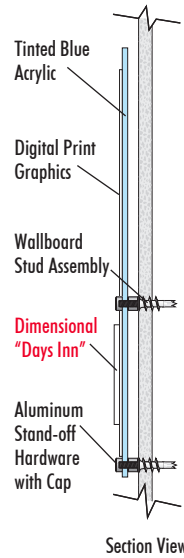

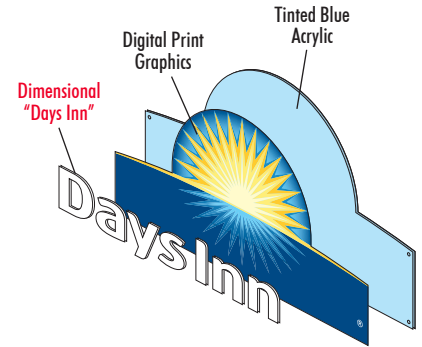

Assembly View of the Layers (hardware not shown)

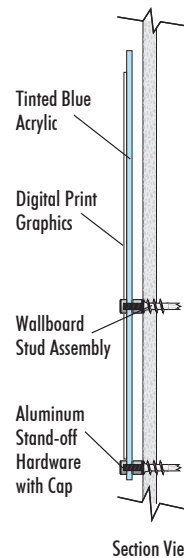
